Generales:

- Getting to know the Mexican Foreign Trade Ventanilla Única Portal (external users).
- External Users management.

Secretaría de Hacienda y Crédito Público:

- Digitalize foreign trade documents.
- Authorization to enter or exit the national territory to or from a different point from the authorized one, within the customs maritime traffic circumscription.
- Application for the merchandise sampling registry.
- Goods in Transit Carriers Registry.
- Authorization to provide electronic data processing services and related services needed for the control of temporal import of trailers, truck-tractors and container lorries.
- Authorization to assign merchandise to the Strategic In-Bond Site regimen.
- Authorization for establishing customs warehouses for the exhibition and sale of foreign and national goods at maritime, border, and international airports, according to what is established on article 121, fraction I of the Customs Law.

- Authorization for the entry or exit of goods to and from the national territory, via pipes, ducts, cables or other transportation method.
- Authorization of foreign trade tax exemption for the goods entering to the national territory according to what is established on Article 61 Fraction IX of the Customs Law (G-E).
- Authorization to provide goods loading, unloading and handling services within a customs warehouse.
- Authorization to provide handling warehousing and safekeeping services of foreign trade goods.
- Authorization to provide services of petition data electronic pre-validation.
- Authorization to temporarily establish a customs warehouse for international exhibitions of selected (local) goods.
- Customs Warehouse Authorization for vehicle assembly or manufacturing processes.
- Request for Certified Copies of Declarations and their attachments.
- Spatial planning of the property to enable goods entry under the Strategic In-Bond Site Regimen and Management Authorization.

- PROSEC Extension (for third parties).
- PROSEC New Program Authorization (for third parties).
